In 2020, we continued to update and improve the website designed for locals and tourists alike to find all the information they need to safely and responsibly recreate in our region. With the pandemic, this was more important than ever and we added COVID information and industry resources. Also through the website, we translated the Family Adventure Guide to the Pikes Peak Region into Spanish and distributed both versions to families through a Covid school lunch pick-up program. We also hosted the Leadership Summit virtually over two days with regional land managers talking about COVID and user impacts on both the resources and their management. In addition, we had speakers share management alternatives and solutions.
We hosted the 3rd annual Litter Letter Project safely with clean-ups across the area filling giant letters that spelled the word "RESILIENT" and stayed on display through October.

PIKES PEAK APEX
We successfully held the largest mountain bike race in North America in 2020, our inaugural year. The Pikes Peak APEX is a unique 4-day mountain bike challenge on the slopes of Pikes Peak, Americas Mountain. The event features exhilarating, exceptionally crafted routes through dirt roads, jeep trails, and the amazing alpine single track that is essential Pikes Peak. The terrain is challenging, but not overly technical. The race draws not only professional riders, but also amateur cyclists looking for a bucket list endurance experience. The Pikes Peak APEX benefits the region's citizens, through economic impact and greater visibility and awareness of the Pikes Peak region as a desirable outdoor recreation destination.

PPORA Stewardship Fund
Through the Pikes Peak APEX, the PPORA Stewardship Fund was launched.
Collaborating with land managers and like-minded advocacy groups, the PPORA Stewardship Fund brings attention and action to the Pikes Peak region's trail system and surrounding lands for multiple uses and users. The Fund supports both the existing and the potential system with priority given to ensure race venue areas and trails emerge more sustainable and better connected for enjoyment by all users in the greater community. Funds were allocated to specific on-the-ground trail projects in the community in 2020 with some funds held over to 2021.
